This letter forwards the report of the announced inspection of your emergency preparedness program conducted by Mr. D. Silk and others of this office on February 1 through February 4, 1994 at the James A. FitzPatrick Nuclear Power Plant, Scriba New York. Preliminary inspection findings were discussed by Mr. Silk with members of your staff on February 4, 1994.

Areas examined during this inspection are important to public health and safety and are described in the NRC Region I Inspection Report that is enclosed with this letter. Within those areas, the inspection consisted of observations by the inspectors, interviews of personnel, and examination of selected procedures and records.

Overall, the inspectors found that, in general, the EP program was well implemented: support from site management was evident; emergency response facilities and equipment were operationally ready; and emergency response organization training was complete. However, the independent audits of the program were found to be potentially weak. No violations of regulatory requirements were identified.
