Subject: Systematic Assessment of Licensee Performance (SALP) and Your Letter FYR 82-99, October 8, 1982

This refers to the SALP for Yankee Nuclear Power Station conducted by this office on August 30, 1982, and discussed with you and your staff at a meeting on September 8, 1982. The list of attendees is provided as Enclosure 1. The NRC Region I SALP Report is provided as Enclosure 2 and covers the period July 1, 1981 to June 30, 1982. Your letter, dated October 8, 1982, submitted pursuant to our letter of September 3, 1982, provided comments on the SALP Report. These letters are included as Enclosures 3 and 4.

Our overall assessment of your performance of NRC licensed activities at the Yankee Nuclear Power Station is that there is an effective and aggressive orientation toward assuring safe operation of the facility. A high level of management attention and involvement in the decision making process is evident for matters affecting plant safety. Based on your performance we find that it is appropriate to continue reduced NRC attention to your activities.

We reviewed your letter of October 8, 1982, and find that the action you are taking to enhance the reliability of the primary vent stack monitors adequately address our concerns noted in the Radiological Controls - Effluent Control and Monitoring section of Enclosure 2. We understand that the modifications to the primary vent stack monitors are to be completed by March 1, 1983. Regarding our comment in the Plant Operations section of Enclosure 2 concerning decreased corporate representative presence onsite compared to that of the previous assessment period, we acknowledge the other measures that you have instituted in addition to the periodic site visits by a corporate representative to foster effective communications between the site and the engineering offices. Based on the discussions during the September 8, 1982 meeting, we have supplemented the SALP report to clarify the situation. In addition, we have made minor editorial and typographical corrections to the report that did not affect our asse sment or conclusions.

We consider that our meeting and subsequent interchange of information were beneficial and improved mutual understanding of your activities and our regulatory program.
