Gentlemen:

I am pleased to respond to your telegram of October 20, 1978 to Chairman Hendrie concerning the design errors in the shear walls of the control building at the Trojan Nuclear Plant. Since this matter is currently pending before an Atomic Safety and Licensing Board whose decision may ultimately be reviewed by the Commissioners, including Chairman Hendrie, your telegram was referred to me for reply.

As mentioned above, the matter of operation of the Trojan facility prior to modifications to the control building is now being considered by an Atomic Safety and Licensing Board. One of the issues before that Board is the manner in which the control building design errors may affect the seismic qualification of other safety-related equipment in the control building. Any decision by the Board with regard to interim operation of the facility will only be made after the equipment qualification issue as well as all other safety-related matters regarding the control building have been fully addressed. Accordingly, we have forwarded your telegram to the Atomic Safety and Licensing Board for the Trojan hearing.

TROJAN DECOMMISSIONING ALLIANCE

TO RENDER IMPARTIAL JUDGMENTS AS TO THE ADEQUACY OF THEIR OWN WORK. EMERGING EVIDENCE HAS ALREADY PROVED THE PRESSING NEED FOR EXTENSIVE HEARINGS ON THIS MATTER. NOW WE HAVE JUST LEARNED THAT, IN ADDITION, SAFETY SYSTEMS DESIGNED TO PROTECT AGAINST THE MOST SERIOUS POSSIBLE NUCLEAR ACCIDENTS AT TROJAN DO NOT MEET THE FEDEBAL STANDARDS. P GF MUST NOT BE ALLOWED TO OPERATE THIS NUCLEAR PLANT. THE DEFECTIVE COOLANT PIPE SYSTEM AFFECTS NOT ONLY THE NUCLEAR R EACTOR BUT ALSO THE SPENT FUEL POOL STORAGE AREA FOR NUCLEAR WASTE AT TROJAN. THE MORE WE FARN ABOUT THE TROJAN PLANT, T HE MORE WE DISCOVER THAT TROJAN'S QUALITY CONTROL SITUATION S A SHOODY MESS WHICH COULD RESULT IN A CATASTROPHE. MISIST THAT THE GOVERNMENT FULFILL ITS RESPONSIBILITIES BY ORDERING AN INDEPENDENT AND COMPLETE INVESTIGATION OF TROJAN'S SAFETY SYSTEMS AND ABYSMAL QUALITY CONTROL. PGE AND THE BECHTEL CONSTRUCTION COMPANY HAVE CLEARLY SHOWN THAT I HEY CANNOT BE RELIED UPON TO INSPECT THEIR OWN FACILITIES, OR
