This letter refers to the safety inspection conducted by Ms. Laurie Peluso of this office on February 7-10, 1994, of activities authorized by NRC License Nos. DPR-21, DPR-65, and NPF-49 at the Northeast Utilities Service Company, Berlin, Connecticut, and to the discussions of our findings held by Ms. Peluso with Mr. Crandall and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection, involving your Radiological Environmental Monitoring Program, are important to public health and safety and are described in the NRC Region I Inspection Report that is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, implementation of the Radiological Environmental Monitoring Program was very effective. The responsible individuals were knowledgeable with respect to implementation of the above programs. No safety concerns or violations of NRC requirements were identified in your program.
