This letter refers to the safety inspection conducted by Dr. Jason C. Jang of this office on February 14-17, 1994, of activities authorized by NRC License Nos. NPF-39 and NPF-85 at the Limerick Generating Station, Units 1 and 2, Limerick, Pennsylvania and to the discussion of our findings held by Dr. J. Jang with Mr. R. Boyce and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are important to public health and safety and included your capability for calculating the projected radiation doses resulting from radioactive liquid and gaseous effluent releases, as described in the NRC Region I Inspection Report that is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, we noted that you had very good projected dose calculation capability. No safety concerns or violations of NRC requirements were identified in your program.
