SUBJECT: NRC INSPECTION REPORT 030-22260/94-01 (NOTICE OF VIOLATION)

This refers to the routine, unannounced inspection conducted by Messrs. William H. Radcliffe and Gilbert L. Guerra, Jr., of this office on February 8, 1994. The inspection included a review of activities authorized by Byproduct Materials License 25-23491-01. At the conclusion of the inspection, the findings were discussed with members of your staff.

The inspection was an examination of activities conducted under the license as they relate to radiation safety and to compliance with the Commission's rules and regulations and the conditions of the license. The inspection consisted of selective examinations of procedures and representative records, interviews of personnel, independent measurements, and observation of activities in progress.

Based on the results of this inspection, certain of your activities appeared to be in violation of NRC requirements, as specified in the enclosed Notice of Violation (Notice).

You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. In your response, you should document the specific actions taken and any additional actions you plan to prevent recurrence. After reviewing your response to this Notice, including your proposed corrective actions and the results of future inspections, the NRC will determine whether further NRC enforcement action is necessary to ensure compliance with NRC regulatory requirements.

The inspectors discovered that the name of the licensee identified on License 25-23491-01 was no longer correct. The inspectors were informed that the business entity of Stensatter Druyvestein and Associates had changed its name to Druyvestein Johnson and Anderson. You are required to request a license amendment from the Nuclear Materials Licensing Branch, NRC Region IV, along with your response to the Notice. Enclosed is Information Notice No. 89-25 "Unauthorized Transfer of Ownership or Control of Licensed Activities," for your review in preparing the license amendment request.
