Gentlemen:


In view of your Generic letters 83-28, & 90-03 dated March 20, 1990 & May 14, 1990. We wish to advise you that we have issued the attached letter to all U.S. operational Nuclear sites using our class 1E Safety Related Equipment.

We have also issued to our original customers (Engine Manufacturers & Packagers) a list of Overseas clients, asking them to notify these sites.

We have taken this action because our equipment was specifically designed for Class 1E Safety Related standby duty, and was not manufactured commercially. All equipment is site specific and as a result many components are not available commercially. We have advised all concerned in order that they may take action now to sustain the safe operation of the equipment for the life of the Power Station.

We trust this information will be of assistance to you.

Gentlemen:

Due to the lack of business and the non response to letters sent out to certain utilities that did not have a complete set of spares for Standby Generators and Static Exciter Voltage Regulator Systems, the Management of Peebles Electric Inc. has decided that the Nuclear Utility Quality Assurance Program **10CFR50 App. B** is no longer cost effective for our business.

Therefore we are compelled to terminate this program. To achieve this with minimum hardship for the licensee, we are advising you, we will accept orders for spare parts needed for the life of your equipment up to June 30, 1994. Orders placed after June 30, 1994 will not be accepted.

Only orders received prior to June 30, 1994 will be processed in accordance with our 10CFR50 App. B program.

We would be pleased to assist you in evaluating your requirements on receipt of your current inventory list for this equipment.

As we have just passed a NUPIC audit all participating members can order direct from Peebles Electric without further auditing. We enclose a parts list with current prices to assist you in the process.
