SUBJECT: NRC INSPECTION REPORT 50-206/94-04; 50-361/94-04; 50-361/94-04
(NOTICE OF VIOLATION)

This refers to the inspection conducted by Messrs. M. D. Schuster and A. B. Earnest of this office on February 7-11, 1994. The inspectors were accompanied by Mr. E. Butcher from the office of NRR. The inspection included a review of activities authorized for your San Onofre Nuclear Generating Stations (SONGS), Units 1, 2, and 3 facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

Based on the results of this inspection, certain licensed activities appeared to be in violation of NRC requirements, as specified in the enclosed Notice of Violation (Notice). The violation is of concern because of your failure to establish adequate controls for the protection of safeguards information. This violation, even though licensee identified, is being cited because the criteria in paragraph VII.B.(2) of Appendix C to 10 CFR Part 2 of the NRC's "Rules of Practice," were not satisfied.

In addition, the inspectors identified one security officer that did not have in his possession the required security equipment as required by 10 CFR Part 73, Appendix B and your physical security plan. This violation is not being cited because the criteria in paragraph VII.B.(1) of Appendix C to 10 CFR Part 2 of the NRC's "Rules of Practice," were satisfied.
