MEETING WITH DUKE POWER TO DISCUSS ENVIRONMENTAL TECHNICAL SPECIFICATIONS FOR MCGUIRE 1 & 2

A meeting was held on November 16, 1978 with representatives of Duke Power Company and the NRC staff to discuss the applicant's comments on the proposed environmental technical specifications (ETS) for McGuire Nuclear Station. A list of attendees is provided as Enclosure 1.

After a brief review of the status of the ETS, specific comments on the draft ETS were discussed. The basis of the discussion was the comments provided by Duke on September 6, 1978, and it centered around definitions, water quality, chemical discharges monitoring, consistency with the EPA NPDES permit, and impingement and entrainment studies. Duke representatives have committed to providing staff with justifications for the changes that have occurred in their monitoring program as specified in the Environmental Report. The applicant is expected to provide further information and justifications for deleting ETS 3.1.1a(3) dealing with water quality monitoring during fish sampling. This information is to include the 316(a) program for the Marshall Steam Plant and a revision of the Environmental Program Description Document (EPDD) to include limited water quality monitoring at sampling location 8.5.

The staff agreed to delete paragraph 1 from the chemical release inventory environmental specification. The staff also agreed to make the ETS parameter definitions consistent with those in the NPDES. We will also review material to be provided by the applicant concerning modification of programs as detailed in their ER and our FES. Wm. H. Regan, Jr.

The applicant will provide this information shortly and continue work on their EPDD. The staff will endeaver to revise the ETS by early January because fuel load is scheduled for February 1979 for Unit 1.
