SUBJECT: REQUEST FOR HISTORICAL CONTRACTOR ACCOMPLISHMENT
 INFORMATION FROM ONSET OF CONTRACT (A 7254) WITH
 LANL FY 82

The subject contract was transmitted to LANL through the Albuquerque DOE Operations Office in May 1981. The objective of the contract was for LANL to provide NRC staff with a review and evaluation assistance on certain parts of the Safety Evaluation Report (SER) for each of twenty-six non-power reactor operating license renewal applications currently docketed through FY 84.

To accomplish the objective, a "cascade" review technique was established wherein several license renewal packages were reviewed in sequence and were, at any one time, in various stages of development or completion.

Following completion of the first two license renewal reviews, a modification to the above approach was discussed, and a different method was field tested. This proved to be successful, and was incorporated into the 1983 and 1984 LANL Work Statement.
