

Gentlemen:

The Commission has issued the enclosed Amendment No. 54 to Facility Operating License No. DPR-3 for the Yankee Nuclear Power Station (Yankee-Rowe). The amendment consists of changes to the Technical Specifications in response to your requests dated November 30, 1976 (Proposed Change No. 119, Supplement 1), September 8, 1978 (Proposed Change No. 163) and October 30, 1978 (Proposed Change No. 164), as supplemented by letter dated November 10, 1978, two (2) submittals dated November 21, 1978 and a letter dated November 27, 1978.

The amendment incorporates provisions in the Technical Specifications required for (1) operation of Yankee-Rowe with the refueled Core XIV, (2) performance of subsequent steam generator inspections in accordance with the added Section 3/4.4.10 "Steam Generators", and (3) inclusion of four manual containment isolation valves in Table 3.6-1.

You have installed the four isolation valves as part of a modification to enhance the safe shutdown capability in the event of damage in certain areas inside the turbine building, due to potential fires. While this modification alleviates our immediate concern, we will continue our review of this modification as part of the resolution of the open items in our review of your fire protection program for Yankee-Rowe.

Copies of our Safety Evaluation and the Notice of Issuance are also enclosed.
