SUBJECT: SUMMARY OF NOVEMBER 30, 1978 MEETING TO DISCUSS THE REQUIREMENTS AND SCHEDULES FOR RELOAD SUBMITTALS FOR THE OYSTER CREEK NUCLEAR GENERATING STATION

On November 30, 1978, representatives of Jersey Central Power and Light Company (JCP&L) and the NRC staff met in Bethesda to discuss the licensing requirements of the reload submittals for the Oyster Creek Nuclear Generating Station. The meeting was held at the request of JCP&L to provide the staff with JCP&L's concept of the information that would be provided for a reload submittal using reload fuel from more than one vendor. Methods used for analysis and degree of rigorous modeling is dependent on the amount of time available for analysis and for staff review and therefore, the schedule requirements became a significant part of the discussion.

JCP&L requested another meeting be scheduled with the staff right after the holidays to better define the actual scope of review and schedule for submittal of the analysis. The staff agreed that another meeting would be beneficial but a definite date was not set. Enclosed is a list of attendees.
