Box 215, Buchanan, New York 10511, of activities authorized by NRC License No. DPR-64 and to the discussions of our findings held by Harry W. Kerch with D. Halama of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter.
