
Dear Mr. Crespo:

I am responding to your letters of December 17, 1993, to Chairman Selin and me concerning your request to establish a Blanket Purchase Agreement (BPA) with your organization for graphic services.

Currently, we have thirteen BPAs for graphic services, four of which are awarded to woman-owned businesses and three of which are awarded to minority businesses, including an Hispanic-owned firm. Because your organization presently does not perform graphic services required by the Nuclear Regulatory Commission, but rather coordinates graphic services performed by other firms, we do not have the basis to establish a BPA with you at this time. When you develop an in-house capability to provide graphic services, we would be happy to meet with you, inspect your facilities, and discuss establishing a BPA with your firm.

I appreciate your interest in our agency and wish you the best in your future endeavors.

Dear Congresswoman Morella:

I am responding to your December 21, 1993, letter in which you request assistance on behalf of your constituent, Mr. Diego Crespo, who is seeking a Blanket Purchase Agreement (BPA) for graphics services with the Nuclear Regulatory Commission (NRC).

Prior to establishing his new firm, Creative Cooperative, Mr. Crespo met with our graphics staff in September 1992 and in March and April 1993 to discuss the possibility of establishing BPAs with two other firms, but he left the employ of these firms before NRC completed its evaluation of their capabilities. Consequently, no further action was taken with respect to these inquiries. In June 1993, Mr. Crespo met with our graphics staff to describe the capabilities of Creative Cooperative. As explained in the enclosed letter to Mr. Crespo, we concluded that Creative Cooperative does not possess the in-house capability to perform graphics services. Should Mr. Crespo develop this capability, we will be happy to schedule a site visit to inspect his facilities and discuss placing a BPA with his firm.

I trust this reply responds to your request.
