SUBJECT: CONFIRMATORY ORDER MODIFYING LICENSE AND DEMAND FOR INFORMATION

We have reviewed the circumstances surrounding the disposal of your well logging source and the expiration of your license. As a result, we are issuing a modified license authorizing you to possess and store the source in accordance with the conditions in the enclosed Confirmatory Order (and the Commission's other requirements) until you can dispose of it. Under our current inspection program, you will be inspected every 2 to 3 years.

Item VI of the Order requires you to submit a detailed, written description of all efforts made to dispose of your source. This description must be submitted within 45 days of the date of the Order.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and your response will be placed in the NRC Public Document Room.
