SUBJECT: NRC INSPECTION AND RADIOLOGICAL SURVEY (REPORT
NO. 999-90003/94011(DRSS))

This refers to the special inspection conducted by Messrs. Donald Sreniawski, Gary Shear, and George M. McCann of this office from October 15 to November 17, 1993, of the Lagoon and Aeration Tank areas at the Southerly Wastewater Treatment Plant (SWTP). This also refers to the telephone conversation between you and Mr. Ray Glinski on February 18, 1994, regarding laboratory analysis results from the samples collected during the inspection. Also included in this inspection was the review of radioanalytical data on December 1, 1993, and February 17, 1994.

The enclosed copy of our inspection report identifies the areas surveyed during the inspection. The inspection consisted of a beta/gamma radiation survey of Lagoon A, the connecting roads surrounding the evaporation ponds, and the Aeration Tank area at the SWTP. The inspection also included the collection and analysis of soil/ash samples from the areas surveyed. This information was used by the NRC in its assessment regarding the conditional release of Lagoon A.

In accordance with 10 CFR 2.790 of the Commission's regulations, a copy of this letter and the enclosed inspection report will be placed in the NRC Public Document Room.
