SUBJECT: FORT ST. VRAIN EARLY WARNING SYSTEM (EWS)

During recent telephone discussions between Mr. M. McBride of your staff and Mr. J. Montgomery of this office, it was learned that a meeting between Public Service Company, the State of Colorado, Weld County, and the U. S. Weather Service was held on October 21, 1982. We further understand that the purpose of the meeting was to discuss and resolve any problems that remained related to the operation and maintenance of the Fort St. Vrain EWS.

The NRC was unable to attend this meeting, but remains concerned about the resolution of the EWS problems. Based on a telephone conversation between Mr. D. Warembourg of your staff and Mr. T. F. Westerman of this office, it is our understanding that you will provide this office with a summary of the EWS issues discussed during the October 21, 1982, meeting and the actions you have taken or will take to correct future system malfunctions.
