DECLARATION OF NEAL DONOVAN-GANTZ

- I, Neal Donovan-Gantz, do declare as follows:
- 1. Since September 1979 I have been a student at the University of California at Santa Cruz, majoring in Environmental Studies. I have completed all of my course work and am currently completing my senior thesis.
- 2. In the spring of 1980 I was an Environmental Intern, placed through the UCSC Environmental Studies Field Program, working with the Committee to Bridge the Gap in Los Angeles. My research project was an assessment of potential impacts of a radioactive waste dumpsite located on Veterans Administration property approximately one mile from UCLA. My study focused on potential impacts of the disposal site on nearby water wells.
- 3. As part of my review, I contacted officials of the relevant agencies to ascertain the location of water wells in the vicinity. These agencies contacted included: the State Department of Water Resources, the State Health Department, the Water Quality Control Board, EFA, the VA, the LA Department of Water and Fower, the LA County Flood Control District, and the Santa Monica Water Division. I furthermore reviewed the available records provided by these agencies.
- 4. The available records indicate wells within a half mile to a mile of UCIA, with numerous additional wells within two miles, including wells which provide water for the City of Santa Monica.
