Dear Sir:

In the above referenced letters, PECO Energy Company (PECO Energy) submitted, in accordance with 10 CFR 50.90, Technical Specification Change Requests (TSCRs) 92-06, 93-04 and 93-27 which requested changes to Appendix A of the Peach Bottom Atomic Power Station (PBAPS) Operating Licenses. The proposed changes concern the removal of references to the Service Platform Hoist, the recalibration of pressure switches using reactor thermal power instead of turbine first stage pressure and changes to Table 3.2.F to accurately describe the main stack high range and reactor building roof vent high range radiation monitors.

PECO Energy hereby requests that our original submittals be revised such that the submitted page 39 for Unit 2 and 3, and pages 77a and 229 for Unit 3 only, be deleted and replaced with the attached revised page 39 for Units 2 and 3, and pages 77a and 229 for Unit 3 only. These pages are being revised to incorporate a recently approved amendment and minor administrative changes. This issue was discussed between Ken Graff (PECO Energy) and Steve Dembek (NRC) on March 9, 1994.



Also, we have concluded that the proposed revisions do not affect the information supporting a finding of No Significant Hazards Considerations and the information supporting the Environmental Impact Assessments.
