As indicated in the enclosed list of DES and FES issuances, several statements have been issued since the Final GEIS on Uranium Milling of September, 1980. However, these later statements have all been issued in relation to specific licensing actions and have not addressed changes in regulations or calculational models for estimating radiological impacts.

In response to your second question, the proposed Domenici amendment to the 1978 Uranium Mill Tailings Radiation Control Act was never enacted into law.
