Enclosed is a copy of Amendment 9 to License No. 47-14060-01, dated May 4, 1992. This amendment is current.

We are taking action with this letter to VOID the application for amendment dated December 21, 1993 and its followup letter dated February 28, 1994. We are taking this action for two reasons. Amendment 9 as written does not prohibit your current operations. The second reason is the extended time needed to complete activities to qualify Mr. Warren Duckett in both the Radiation Safety Officer position and as an authorized gauge repositioner-surveyor and to qualify Mr. Thomas Turner as a gauge repositioner-surveyor.

We understand that Mr. Duckett is scheduled to attend a training course in June, 1994. We believe that Mr. Duckett would more completely meet our requirements and benefit from additional instruction in gauge movements, surveys, and maintenance actions. Mr. Turner would also more adequately meet the needed training for gauge movements, surveys and maintenance activities.

Because we are voiding this amendment application, there will be no fee charged when reapplying for this amendment. Your letter should request reopening of Mail Control Number 255705 and reference this letter.

The letter of application submitted after the completion of training for Mr. Duckett, and for Mr. Turner if you should choose, should include copies of training certificates, accompanied by a time and subject matter description. The letter should propose Mr. Duckett as Radiation Safety Officer, with Mr. Turner as alternate; remove Messrs. Foltz, Yates and Chase from the proper conditions. You should also state that Messrs. Duckett and Turner shall provide local specific training to individual users on a once per 12 month basis and that records of the training shall be maintained.



The following comments are provided in response to your letter dated February 9, 1994 concerning updating and correction of entries for our reference license.


1. Mr. Warren A. Duckett, in assuming his new duties, will receive "Radiation Safety Officer" training no later than July 1, 1994. A copy of the proposed course outline is attached for your review. Item #11 should be revised upon completion of this training.
2. Item #15 should be revised to remove the names of Messrs. Foltz and Chase, and to replace with Mr. Warren A. Duckett and Mr. Thomas W. Turner.
3. Training to be given to others, when required, will be provided by Messrs. Duckett and Turner. Both individuals have years of technical experience including previous training activity in other technical disciplines.

In addition, Item #12 should be revised to delete James E. Foltz and Mr. Kerry Yates. Mr. Warren A. Duckett should be added.

LICENSE APPLICATION (REFERENCE: MAIL CONTROL 255705;

This refers to Mr. Kerry D. Yates's letter dated December 21, 1993 to amend License No. 47-14060-01.

It is important that you understand that Amendment 9 is the current issue of your license, and it continues in effect until an amended license is issued by this office. A copy of Amendment 9 is enclosed. Since the departure of Mr. Kerry Yates, Mr. Thomas Turner serves as the Radiation Safety Officer. Upon receipt of a certificate of completion of acceptable training, Mr. Warren Duckett may be named as Radiation Safety Officer. Also, since Messrs. Foltz and Chase have left the plant, only specifically licensed individuals may service gauges at your facility.

We find that we need additional information to continue processing your amendment request. We have enclosed a copy of DRAFT "Guide for the Preparation of Applications for Licenses for the Use of Sealed Sources in Non-portable Gauging Devices" (Task FC 404-4) as an aid.

Please provide answers to these questions:

1. Please provide information concerning the scheduling and completion of an acceptable program for Mr. Duckett. Acceptable training guidelines are indicated in Item 7 of the DRAFT Guide.
2. Item 15 in the current license authorizes two individuals, Messrs. Foltz and Chase, to install, perform an initial radiation survey, relocation or removal from service of gauges within the facility. You may wish to qualify other individuals and submit their qualification certificates and outline of training received to support their nomination. Such training should follow along the lines of training as in Item 7 of the DRAFT Guide.

3. Training to be given to others, as indicated in Item 8, such as plant operators, should be given by an instructor with more training than the minimum training recommended for a "responsible individual" in Item 7, including training in how to provide instructions.

When replying, please refer to Mail Control No. 255705 and provide 2 copies of your response. If we do not receive a reply from you within 30 calendar days from the date of this letter, we shall assume that you do not wish to pursue your application.

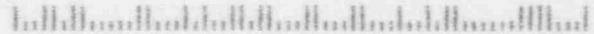
