SUBJECT: EXAMINATION REPORT NO. 50-245/94-04 (OL)

During the weeks of January 10 and January 31, 1994, the NRC administered initial examinations to employees of your company who had applied for licenses to operate the Millstone Nuclear Power Station, Unit 1. At the conclusion of the examinations, the preliminary findings were discussed with those members of your staff identified in the enclosed report.

All six of the applicants passed the initial examinations. Section 3.0 of the enclosed report contains additional details of the applicants performance and the NRC examiners' observations.

The reference material submitted for examination preparation and license application submittal did not meet the expectations established in our letter dated October 7, 1993, and the guidelines of ES-201 of NUREG-1021, "Examiner Standards," Rev. 7. The problems with reference material and license application submittal are described in sections 3.4 and 3.5 of the enclosed report. We request that you carefully review your initial examination preparation practices to assure more timely and complete submittal of reference material and individual operator license applications.
