Dear Mr. Lee:

In response to Mr. Warembourg's January 21, 1983 letter concerning the apparent discrepancies which exist between the perceived contents of License No. DPR-34, we have reviewed your understanding of the license contents and feel we have a resolution for the discrepancies.

The major discrepancy we noted involves the inadvertent elimination of the subparagraph heading in License Condition 2.C.(4) and subparagraphs 2.C.(4)b. and 2.C.(4)c., through the issuance of License Amendment No. 25 on March 2, 1982. The change approved by Amendment No. 25 should have only indicated changes to License Condition 2.C.(4)a. and not revision of the entire 2.C.(4). We have, therefore, enclosed a correction to License Amendment No. 25 in the form of revised license pages.

The discrepancy in the actual number of pages included in License No. DPR-34, which was our major concern, is purely an administrative preference. We do not include the original transmittal letter as part of the actual license; hence, your pages 1 and 2 are not part of the actual license. Likewise, the Notice of Issuance and Amendment No. 3 to Indemnity Agreement No. B-50 are not included as actual license pages. Therefore, with the inclusion of those sections of License Condition 2.C.(4) which were inadvertently omitted with the issuance of Amendment No. 25, the license documents held by your organization and ours will be identical.

We apologize for any inconvenience our inadvertent omission may have caused. If you have any questions on this matter, please contact your Project Manager.


