Subject: Report No. 50-370/82-27

This refers to the routine safety inspection conducted by Mr. H. L. Whitener of this office on September 22-28, 1982, of activities authorized by NRC Construction Permit No. CPPR-84 for the McGuire facility. Our preliminary findings were discussed with Mr. Wilkinson, Acting Plant Manager, at the conclusion of the inspection.

Areas examined during the inspection and our findings are discussed in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspectors.

Within the scope of this inspection, no violations were disclosed.

During the inspection it was found that certain activities under your license appeared to deviate from generally accepted industry practice and have safety significance. This item identified in the Notice of Deviation enclosed herewith as Appendix A. Please provide us in writing within 30 days of your receipt of this letter your comments including a description of corrective actions that have been or will be taken, corrective actions which will be taken to avoid further deviations, and the date your corrective actions were or will be completed.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosures will be placed in the NRC's Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1).

The responses directed by this letter and the enclosures are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.

Should you have any questions concerning this letter, we will be glad to discuss them with you.
