Varela of this office on January 4-7, 1983 at Limerick Generating Station Unit 1, Limerick, Pennsylvania of activities authorized by NRC License No. CPPR-106 and to the discussions of our findings held by Mr. A. Varela with Mr. J. M. Corcoran of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter.
