Gentlemen:

Subject: Report Nos. 50-321/82-36 and 50-366/82-34

This refers to the routine safety inspection conducted by Mr. A. L. Cunningham of this office on November 30, December 6, 1982, of activities authorized by NRC Operating License No. DPR-57 and NRC License No. NPF-5 for the E. I. Hatch facility. Our preliminary findings were discussed with Mr. T. V. Greene, Assistant Plant Manager, at the conclusion of the inspection.

Areas examined during the inspection and our findings are discussed in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

During the inspection, it was found that certain activities under your license appear to violate NRC requirements. This item and references to pertinent requirements are listed in the Notice of Violation enclosed herewith as Appendix A. Elements to be included in your response are delineated in Appendix A. This violation is a continuing violation which was initially brought to your attention in our letter dated November 4, 1981. As discussed in a telephone conversation between Mr. H. C. Dance of this office and Mr. P. D. Rice of your staff, on December 13, 1982, had you implemented the corrective actions described in your letter of December 30, 1981, this citation would be unnecessary. Please give this matter your particular attention in your response to this letter. Your response and findings of our future inspections will determine if further enforcement action is appropriate.

During the inspection it was found that certain activities under your license appeared to deviate from commitments to the Commission and have safety significance. This item identified in the Notice of Deviation enclosed herewith as Appendix B. Please provide us in writing within 30 days of your receipt of this letter your comments including a description of corrective actions that have been or will be taken, corrective actions which will be taken to avoid further deviations, and the date your corrective actions were or will be completed.

We have examined actions you have taken with regard to previously identified enforcement matters. These are discussed in the enclosed inspection report.
