References (a), (b), (c), (d), (e) and (f) requested that the Commonwealth Edison Company provide, within sixty (60) days, supplemental information concerning our previous responses to IE Bulletin No. 81-03 for our Dresden, Quad Cities, LaSalle County, Byron and Braidwood Stations. Please note that no such request for additional information was received concerning our Zion Station.


We are currently preparing our responses to References (a), (b) and (c) for which the NRC Staff has requested a submittal by February 8, 1983. However, References (e) and (f) requested a submittal by March 22 and 28, 1983 respectively.

It is our judgement that a single Commonwealth Edison Company submittal is in order concerning this matter. Therefore, we hereby request NRC Staff approval to delay the due date for our response to References (a), (b), (c) and (e) until March 28, 1983, at which time we will submit such information along with our response to Reference (f).
