SUBJECT: COMBINED NRC INSPECTION REPORT NOS. 50-245/94-10, 50-336/94-12
AND 50-423/94-12

This letter transmits the findings of an announced safety inspection conducted by Mr. Carl Sisco of this office from February 14-18, 1994, at the Millstone Unit 1 Training Center, Waterford, CT. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed report.

The inspection consisted of observations of licensed operator requalification training, nonlicensed operator classroom training and a review of training department procedures. The operator training programs are directly related to the safe operation of the plant.

As a result of this inspection, we found that training administered to both licensed and nonlicensed operators was conducive to safe plant operations. Also, the training was conducted in accordance with established training department procedures.

Several open items, detailed in combined NRC Inspection report 50-245/93-28, 50-336/93-23, and 50-423/93-25, were closed and were detailed in section 3.0 of the enclosed report.

Also, this report documented the operator training programs status meeting conducted in the Regional Office on February 14, 1994.


