This refers to the special inspection conducted by Ms. C. D. Perny of this office on October 1, 1982, of activities authorized by NRC Operating License No. DPR-72 at the Crystal River 3 facility, and to the discussion of our findings held with Mr. E. M. Howard, Director, Site Nuclear Operations, and Mr. Q. B. DuBois, Assistant Plant Manager, at the conclusion of the inspection.

Areas examined during this inspection included your physical security program as implemented under the provisions of Title 10, Code of Federal Regulations, Part 73, "Physical Protection of Plants and Materials" and the specific requirements of your approved security plan. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

The enforcement action related to this inspection was addressed to Florida Power Company in a letter dated December 27, 1982, from Mr. James P. O'Reilly, Regional Administrator.

The material enclosed herewith contains Safeguards Information as defined by 10 CFR 73.21 and its disclosure to unauthorized individuals is prohibited by Section 147 of the Atomic Energy Act of 1954, as amended.
