NOTICE OF VIOLATION

As a result of the inspection conducted July 23, 1982 and in accordance with the NRC Enforcement Policy (10 CFR Part 2, Appendix C), 47 FR 9987 (March 9, 1982), the following violations were identified:

A. License Condition 6, as amended May 14, 1982, authorizes the licensee to possess only up to 5 mCi each of carbon-14 and phosphorus-32, and 1.25 mCi of ruthenium-103.

Contrary to the above requirement, at the time of the inspection, the licensee was found to have possessed 10 mCi of hydrogen-3 and 1.92 mCi of chromium-51 EDTA which was not authorized by the license.

This is a Severity Level IV violation (Supplement VI).

B. License Condition 17 states that licensed materials shall be utilized in accordance with statements, representations, and procedures contained in application dated October 16, 1978. Item 15 of the October 16, 1978 application states that swipes and monitoring of work areas with a geiger counter will be performed weekly.

Contrary to the above requirement, at the time of the inspection, weekly surveys had not been performed since the last inspection on June 19, 1979.

This is a Severity Level IV violation (Supplement VI).

C. 10 CFR 20.401 requires that each licensee shall maintain records of sanitary sewer system disposals made pursuant to 10 CFR 20.303 until the Commission authorizes their disposition.

Contrary to the above requirement, at the time of the inspection, records of sanitary sewer system disposals had not been maintained since the last inspection on June 19, 1979.

This is a Severity Level V violation (Supplement IV).

D. 10 CFR 20.407 requires that all persons specifically licensed by the Commission shall within the first quarter of calendar years 1979 and 1980 submit a statistical summary report of personnel monitoring data for the preceeding calendar years 1978 and 1979 to the Director of Management and Program Analysis, U.S. Nuclear Regulatory Commission, Washington D.C. 20555.

Contrary to the above requirement, at the time of the inspection, a statistical summary report for the calendar year 1979 had not been submitted to the Director of Management and Program Analysis during the first calendar quarter of 1980.

This is a Severity Level V violation (Supplement IV).

Pursuant to the provisions of 10 CFR 2.201, the State of Alaska, Department of Fish and Game, Soldotna, Alaska is hereby required to submit to this office within thirty days of the date of this Notice, a written statement or explanation in reply, including: (1) the corrective steps which have been taken and the results achieved; (2) corrective steps which will be taken to avoid further items of noncompliance; and (3) the date when full compliance will be achieved. Consideration may be given to extending your response time for good cause shown.
