Regarding the Virginia Electric and Power Company letter dated February 1, 1994, which transmitted Revision 32 to the North Anna Physical Security Plan, we have determined that the revision is acceptable, except as noted in the enclosure to this letter.

NRR's analysis of the Safety System Outage Modification Inspection (SSOMI) findings addressing the adequacy of security systems associated with certain equipment located outside the protected area has determined that these equipment structures, referred to as Secondary Security Controlled Areas (SSCAs), will not be required to have any additional security measures.

As a result of reviewing Revision 32, we have determined that those applicable portions of Revision 28 to the physical security plan submitted by letter dated December 14, 1992, are also acceptable

Since Revisions 28 and 32 contain Safeguards Information of a type as specified in 10 CFR 73.21, these revisions are being withheld from public disclosure.
