Dear Mr. Potapovs:

Pursuant to N.R.C.'s request, we are providing you with copies of two reports prepared by N.C. Kist and Associates, Inc. dated January 19, 1982 and January 23, 1982 along with a cover letter and accompanying hand-written report from Peter Rowe dated January 8, 1982 and January 9, 1982 (hereinafter "the Reports").

By providing these Reports, Hayward Tyler Pump Company ("H.T.P.C.") does not waive the attorney-client privilege applicable to them, nor does it waive any other applicable privileges or protective doctrine.

H.T.P.C. respectfully claims that these documents are entitled to confidential treatment. The company also claims confidential treatment for all non-public information related to H.T.P.C. and its affairs obtained by the N.R.C. Since the enclosed documents are investigatory reports obtained by the N.R.C. in connection with a potential or concrete possibility of law enforcement proceedings, they are subject to be exempt from disclosure under Exemption 4 of the Freedom of Information Act. Since they contain confidential commercial information relating to H.T.P.C., the disclosure of which would have a damaging effect on certain H.T.P.C. actions and to its competitive position, the Reports are also exempt under Exemption 4.


The confidentiality available to H.T.P.C. and its employees, officers and directors under the Privacy Act of 1974 is also applicable to these Reports.

- 4) Finally, these documents and all copies will be returned to H.T.P.C. upon completion of this investigation or I will be given written notification that these documents and all copies are destroyed.

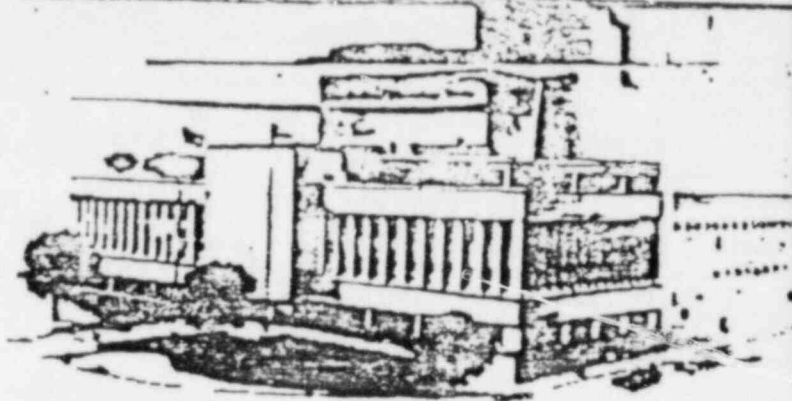

Under the terms of the Freedom of Information Act, I am requesting copies of all draft inspection and investigation reports provided by the U.S. Nuclear Regulatory Commission to Hayward Tyler Pump Co. I also need copies of the transmittal letter for those reports as it was written before being altered by Karl Seyfrit, deputy regional administrator for NRC Region IV. Also, please provide a copy of the letter as written before its alteration.

Additionally, I am requesting all copies of inner-office letters, memorandums, notes, etc., both in Arlington and Washington, which refer directly or indirectly to the Hayward Tyler Pump Co., its products, employees, officials, attorneys, consultants or any other persons or entities associated with the firm. And I want copies of all letters, memorandums, notes or other correspondence between officials or employees of the NRC and any of the above-mentioned people, companies or other entities. Include logs of all phone conversations between any or all of the above.

Please provide copies of all complaints submitted to the NRC against Hayward Tyler Pump Co.

Also requested are copies of all letters, memorandums, notes or other correspondence or records referring to Marcus Rowden since June 1977. Include all correspondence to or from Rowden or his employees and logs of telephone conversations with him or his employees.

Please identify all persons present at a meeting on or about Feb. 12, 1982, at the Arlington, Texas, office in which the draft inspection and investigation reports were provided to Hayward Tyler Pump Co. representatives.

Please provide copies of I&E Reports 81-12 and 81-20 for Comanche Peak.
