Gentlemen:

This refers to your letter of July 16, 1982 in response to the Notice of Violation and Proposed Imposition of Civil Penalties sent to you with our letter of June 17, 1982. Our letter concerned violations found during the physical security inspection conducted by Region V at the San Onofre Nuclear Generating Station, Unit 1, during January 10-12 and February 8-12, 1982.

After careful consideration of your response, and for the reasons given in the Appendix to the enclosed Order, we have concluded that the violations did occur as set out in the Notice of Violation and Proposed Imposition of Civil Penalties. We have also given careful consideration to your request for remission of the proposed penalties and have concluded that no adequate reasons have been stated as to why the penalties should be reduced or mitigated. Accordingly, we hereby serve the enclosed Order on the Southern California Edison Company, imposing civil penalties in the amount of Sixty Thousand Dollars.

In accordance with Section 2.790 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, a copy of this letter and the enclosures will be placed in the NRC Public Document Room.
