Enclosed for your review and approval in accordance with 10 CFR 50.90 are six (6) copies of the January 1983, "Physical Security Plan, San Onofre Units 1, 2 and 3." This new Physical Security Plan for San Onofre is written with the format of and to meet the intent of NUREG-0908: Acceptance Criteria for the Evaluation of Nuclear Power Reactor Security Plans, July 1982. This January 1983 plan, when approved and implemented, will replace the currently in force March 1981 "Physical Security Plan, San Onofre Units 1, 2 and 3" including Revisions, with the exception of Chapter 8.0 - Safeguards Contingency Plan. This Chapter 8.0 - Safeguards Contingency Plan will be editorially changed and re-submitted in the near future as a separate companion document to the security plan.

Based on our discussions with Mr. Charles Gaskin of the Office of Nuclear Materials Safety and Safeguards, SCE will have revised the appropriate security procedures and completed necessary training to fully implement this January 1983 plan three months after formal approval is received. At the time of full implementation of this January 1983 plan, the March 1981 plan with Revisions will be superseded with the exception of Chapter 8.0 - Safeguards Contingency Plan which will remain in force until the revised Safeguards Contingency Plan is approved and implemented.

We have determined that this January 1983, "Physical Security Plan, San Onofre Units 1, 2 and 3" is a Class II Amendment as defined in 10 CFR 170.22. Accordingly, a check for \$1,200.00 is enclosed as required.

The enclosure hereto contains "Safeguards Information" as specified in 10 CFR Section 73.21 and should, therefore, be withheld from public disclosure.
