This letter refers to the enforcement conference held with you and other members of your staff, and with Michael F. Weber and other members of the NRC staff on March 4, 1994, relating to activities authorized by the NRC license issued to Westinghouse Electric Corporation, Resource Energy Systems Division. It is our view that this conference was beneficial because it improved your understanding of concerns regarding the violations identified during our inspection conducted from January 31 to February 10, 1994 following the loss of a fixed gauge containing 100 millicuries of cesium 137. The conference also improved our understanding of your response to this incident. The conference is summarized in the enclosed Enforcement Conference report.

Enforcement action resulting from this inspection will be transmitted to you under separate cover.

In accordance with Title 10, Code of Federal Regulations, Section 2.790, a copy of this letter and its enclosure will be placed in the NRC Public Document Room. No reply to this letter is required. Your cooperation with us in this matter is appreciated.






