This refers to the meeting conducted between you and myself and members of our staffs on August 9, 1982, at Clinton Power Station in Clinton, Illinois. The purpose of this meeting was to discuss your proposals with respect to continuing construction work activities at the Clinton Power Station.

The enclosed copy of our report identifies areas discussed during the management meeting.

In accordance with 10 CFR 2.790 of the Commission's regulations, a copy of this letter and the enclosed meeting report will be placed in the NRC's Public Document Room. If this report contains any information that you (or your contractors) believe to be exempt from disclosure under 10 CFR 9.5(a)(4), it is necessary that you (a) notify this office by telephone within ten (10) days from the date of this letter of your intention to file a request for withholding; and (b) submit within twenty-five (25) days from the date of this letter a written application to this office to withhold such information. If your receipt of this letter has been delayed such that less than seven (7) days are available for your review, please notify this office promptly so that a new due date may be established. Consistent with Section 2.790(b)(1), any such application must be accompanied by an affidavit executed by the owner of the information which identifies the document or part sought to be withheld, and which contains a full statement of the reasons which are the bases for the claim that the information should be withheld from public disclosure. This section further requires the statement to address with specificity the considerations listed in 10 CFR 2.790(b)(4). The information sought to be withheld shall be incorporated as far as possible into a separate
