Subject: Inspection 50-320/82-16

This refers to the special safety inspection conducted by Mr. B. O'Neill of this office on December 6, 1982 - January 14, 1983, of activities authorized by NRC license DPR-73 and to the discussions of our findings held by Mr. O'Neill with Mr. J. Hildebrand and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, measurements made by the inspector, and observations by the inspector.

Our inspector also verified the steps you have taken to correct the violations brought to your attention in the enclosures to our letters dated May 28, 1980, October 29, 1981, January 11, 1982, June 22, 1982, June 30, 1982, and September 14, 1982. We have no further questions regarding your action at this time.

Within the scope of this inspection, no violations were observed.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosures will be placed in the NRC Public Document Room unless you notify this office, by telephone, within 10 days of the date of this letter and submit written application to withhold information contained therein within 30 days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1).
