## Gentlemen:

Thank you for your letter dated January 11, 1983, concerning the qualifications of your radiochemistry supervisory staff with reference to the requirements of ANSI Standard N18.1-1971.

We understand, based on a telephone co ersation on January 28, 1983, between Mr. D. Farrar of your staff and Mr. R. Greger, that you have evaluated the acceptability of Messrs. T. Gilman and S. McDonald for the positions of Lead Chemist and Lead Health Physicist, respectively, in accordance with the qualification criteria in ANSI N18.1-1971 Sections 4.3.2 and 4.4; and that your evaluation determined that Mr. McDonald meets the qualification criteria of ANSI N18.1-1971 Section 4.4.4, but that Mr. Gilman does not currently meet the qualification criteria of ANSI N18.1-1971 Section 4.3.2 or 4.4.3. We further understand that until such time that Mr. Gilman meets the qualification criteria of ANSI N18.1-1971 Section 4.3.2 or 4.4.3 technical evaluations performed under the cognizance of the Lead Chemist will be performed by a chemist who meets the qualification criteria of ANSI N18.1-1971 Section 4.4.3, Mr. McDonald will meet with Mr. Gilman approximately weekly for the purpose of providing technical guidance to Mr. Gilman, and the chemists and Mr. McDonald will be advised of these additional responsibilities. We further understand that you intend to send Mr. Gilman to an appropriate BWR chemistry/radiochemistry traini g course before determining he meets the qualification criteria of ANSI N18.1-1971 Section 4.3.2 or 4.4.3.
