SUBJECT: NRC INSPECTION REPORT 50-445/94-07; 50-446/94-07

This refers to the inspection conducted by Mr. L. T. Ricketson of this office on March 7-11, 1994. The inspection included a review of activities authorized for your Comanche Peak Steam Electric Station, Units 1 and 2, facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress. The results of this inspection are documented in the enclosed report.

It was identified that the collection of meteorological data was not monitored on a monthly basis. This was in violation of station procedures. This violation is not being cited because the criteria in paragraph VII.B.1 of Appendix C to 10 CFR Part 2 of the NRC's "Rules of Practice," were satisfied. This violation did not impact on the safety of your facility, and your staff took prompt and effective actions to correct the problem.

One unresolved item was identified concerning your ability to achieve 90 percent recovery of meteorological data. This matter is discussed in Section 1.4 of the enclosed inspection report.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosures will be placed in the NRC Public Document Room.


