It has come to our attention that we have a statement in our Security Plan that we neglected to put in our Training and Qualification Plan. Therefore, attached as Enclosure (1) we are submitting a changed page to the LACBWR Training and Qualification Plan. This change was previously approved in our Security Plan; consequently, we feel this is a 10CFR50.54p change which does not degrade security.

It is requested that Enclosure (1) be withheld from public disclosure pursuant to 10CFR, Section 73.21, requirements for the protection of Safeguards Information.

A copy of Form L-#59 is enclosed; it is requested that it be completed and returned to LACBWR in the self-addressed envelope to verify receipt.


