SUBJECT: NRC INSPECTION REPORT NOS. 50-334/94-04 AND 50-412/94-04

This refers to the inspection conducted by Messrs. L. Rossbach, P. Sena, and S. Greenlee of this office from February 8 to March 14, 1994. The inspection included a review of activities authorized for your Beaver Valley Power Station in Shippingport, Pennsylvania. At the conclusion of the inspection, the findings were discussed with Messrs. D. Sperry and G. Thomas, and other members of your staff.

Areas examined during the inspection are identified in the report. The inspection consisted of document reviews, interviews, and observation of activities important to public health and safety. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements.

Overall, the plants were operated safely; however, a non-cited violation was identified involving inadvertent isolation of the gaseous waste system oxygen analyzers. This violation is not being cited because of its minor safety significance and your corrective actions.

No reply to this letter is necessary. Your cooperation with us is appreciated.
