02 | During normal operation, while conducting surveillance testing on the reactor low
03 | water level scram switch 02-3-LIS-101D, setpoint was found less conservative than
04 | 58.0 inches of water as required by T.S. Table 3.1-1. The found value was 60.9 inches
05 | of water. Other trip channels of the same parameter were available and had setpoints
06 | within the T.S. The event did not represent a significant hazard to the public
07 | health and safety.
