The enclosed report refers to the inspection conducted by Mr. Frank Jaggar of the Idaho National Engineering Laboratory and Mr. C. Osterholtz of this office on March 7-11, 1994. The inspection evaluated activities at the Point Beach Nuclear Plant, Units 1 and 2, authorized by NRC Operating License Numbers DPR-24 and DPR-27. We discussed our inspection findings with Mr. A. Cayia and members of your staff at the exit interview on March 11, 1994.

The purpose of the inspection was to assess the licensed operator requalification program. The inspectors reviewed training administrative procedures, representative records, requalification training materials, and observed licensed operators during requalification examination administration. Additionally, the inspectors interviewed members of the operations and training staffs.

Weaknesses were identified in the administrative procedures which govern your requalification program (section 2.1.1). However, facility management committed to correcting these weaknesses by 1995. Additionally, one minor deficiency in an abnormal operating procedure caused some confusion among crew members observed during the dynamic simulator examination (Section 2.6). Overall, the inspectors concluded that the licensed operator requalification training program was being implemented in accordance with 10 CFR Part 55 requirements.
