SUBJECT: RADIOLOGICAL EFFLUENT TECHNICAL SPECIFICATIONS (RETS) AND OFFSITE DOSE CALCULATION MANUAL (ODCM)

Re: James A. FitzPatrick Nuclear Power Plant

Please find enclosed revised Technical Evaluation Reports (TER), "Comparison of Plant and Model Radiological Effluent Technical Specifications" and "Plant Offsite Dose Calculation Manual", James A. FitzPatrick Nuclear Power Plant, dated August 10, 1982. These TERs reflect our initial review of your proposed RETS and ODCM as well as the agreements reached during the May 26-27, 1982 site visit. Also enclosed is a copy of the trip report to the FitzPatrick plant, which summarizes the results of that visit.

This is a request for the final submittal of the Radiological Effluent Technical Specifications in accordance with the enclosed report. In addition, you are also requested to submit an Offsite Dose Calculation Manual as agreed to during the meeting. In order to finalize this item in consonance with the schedule established during the site visit you are requested to provide the requested information within 60 days of receipt of this letter.

The reporting and/or recordkeeping requirements contained in this letter affect fewer than ten respondents; therefore, OMB clearance is not required under P.L. 96-511.
