SUBJECT: NRC INSPECTION REPORT 030-08559/94-01

This refers to the routine, unannounced inspection conducted by Mr. Gilbert L. Guerra, Jr., of this office on March 22, 1994. The inspection included a review of activities authorized by Byproduct Materials License 03-15093-01. At the conclusion of the inspection, the findings were discussed with members of your staff.

The inspection was an examination of activities conducted under the license as they relate to radiation safety and to compliance with the Commission's rules and regulations and the conditions of the license. The inspection consisted of selective examinations of procedures and representative records, interviews of personnel, independent measurements, and observation of activities in progress.

No violations or deviations were identified; therefore, no response to this letter is required.

The inspector had the opportunity to tour the National Center for Toxicological Research and observe activities in progress. He concluded from discussions with users of byproduct material that they were knowledgeable about their radiation safety duties and NRC requirements. The inspector also noted that byproduct material storage and waste was properly handled in the laboratories. Also, records required by these activities were in order.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter will be placed in the NRC Public Document Room.
