SUBJECT: CORRECTION TO DEMAND FOR INFORMATION


In reviewing the Demand for Information sent to you on March 11, 1994, it has come to my attention that section 3, paragraph 8 had two erroneous references. Paragraph 8 should read:

8. On or about April 23, 1991, Dr. Cunningham changed the area where byproduct material is used for high dose rate afterloader calibration procedures from the shielded therapy room at the Greater Harrisburg Cancer Center to an area outside the treatment room and outside of the building, and, as of that date, the licensee had not applied for or received a license amendment authorizing the change.
