Subject: Proposed Site Remediation Plan

Your letter dated July 6, 1989, documenting your proposed site remediation action plan, it has been reviewed. Your plan is generally acceptable provided the following actions are accomplished:


1. Remove and dispose of as radioactive waste all surface soil contamination that exceeds the level of 15 picocuries per gram of soil.
2. Conduct radiological surveys following the removal of contaminated soil to assure that all areas in the owner controlled property are within 15 picocuries per gram. Results of these surveys are to be submitted to the Region I office for approval.
3. Estimate the potential for any buried radiological waste in the northeast corner of the Process Technology of North Jersey site. Provide an evaluation of whether any remaining material can be located and removed. If there is a potential for remaining material, identify your plan for monitoring the suspect area to verify that migration of activity is not occurring.
4. Confirm that, in the event of anticipated termination of licensed activity, immediate action will be taken to reduce surface soil contamination to less than eight (8) picocuries per gram prior to such action.
