This refers to your letters dated January 12, 1982 and August 10, 1982, in response to our letter dated December 10, 1981.

Thank you for informing us of the corrective and preventive actions documented in your letters. These actions will be examined during a future inspection of your licensed program.

We have carefully reviewed your comments relative to Violations A and C. The responsibility for assuring compliance with license conditions rests with the license holder. Our decision not to impose a civil penalty does not alter the fact that serious violations did occur and that your management system failed to ensure adequate controls over termination procedures and personnel access to vital areas, which could have minimized the potential for these violations. Based on the above considerations, the violations remain as identified in our letter dated December 10, 1981. Further, similar violations in the future may be subject to escalated enforcement action.

In accordance with 10 CFR 73.21 of the NRC's regulations, documentation of findings of your facility security measures for physical protection are deemed to be Safeguards Information. Each person who produces, receives, or acquires Safeguards Information is required to ensure that it is protected against unauthorized disclosure. Therefore, the attachments to your letter will not be placed in the Public Document Room and will be distributed pursuant to 10 CFR 73.21(c).
