Gentlemen:

This refers to the inspection conducted by Mr. W. E. Foster of this office on July 13-15, 1982, of your facility at Danbury, Connecticut, associated with the manufacture of electronic instrumentation and control systems and to the discussions of our findings with Messrs. L. E. Goodsell, Jr., G. L. Schoenbaum, and F. Butler of your staff at the conclusion of the inspection.

This inspection was made as a result of the issuance of three 10 CFR Part 50.55(e) reports by the Tennessee Valley Authority. The reports pertained to deficient field buffer cards in the Solid State Control Systems that have been furnished to the Bellefonte Nuclear Plant, Unit Nos. 1 and 2.

Areas examined and our findings are discussed in the enclosed report. Within these areas, the inspection consisted of an examination of procedures and representative records, interviews with personnel, and observations by the inspector.

During the inspection it was found that the implementation of your QA program failed to meet certain NRC requirements. The specific findings and references to the pertinent requirements are identified in the enclosures to this letter.

Please provide us within 30 days from the date of this letter a written state ment containing: (1) a description of steps that have been or will be taken to correct these items; (2) a description of steps that have been or will be taken to prevent recurrence; and (3) the date your corrective actions and preventive measures were or will be completed. Consideration may be given to extending your response time for a good cause shown.

The response requested by this letter is not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.
