SUBJECT: NRC INSPECTION REPORT NO. 030-10749/90001(DRSS)

This refers to three separate inspections conducted by Messrs. D. R. Gibbons and J. L. Cameron of this office and C. G. Jones of Headquarters from the period July 24 through August 13, 1990. The inspections included a review of activities authorized for your Green Bay, Wisconsin facility and included a field inspection of a radiographer at Oshkosh, Wisconsin on July 24-25, 1990. On August 8, 1990, the findings were discussed with you.

The enclosed copy of our inspection report identifies areas examined during the inspections. Within these areas, the inspections consisted of a selective examination of procedures and representative records, observations, and interviews with personnel.

Based on the results of these inspections, 11 apparent violations were identified and are being considered for escalated enforcement action in accordance with the "General Statement of Policy and Procedure for NRC Enforcement Actions" (Enforcement Policy), 10 CFR Part 2, Appendix C (1990). Accordingly, no Notice of Violation is presently being issued for these inspection findings. In addition, please be advised that the number and characterization of apparent violations described in the enclosed inspection report may change as a result of further NRC review.

An enforcement conference to discuss these apparent violations has been scheduled for September 13, 1990 at 1:00 p.m. (CDT). The purposes of this conference are to discuss the apparent violations, their causes and safety significance; to provide you the opportunity to point out any errors in our inspection report; to provide an opportunity for you to present your proposed corrective actions; and to discuss any other information that will help us determine the appropriate enforcement action in accordance with the Enforcement Policy. You will be advised by separate correspondence of the results of our deliberations on this matter. No response regarding the apparent violations is required at this time.
